Goods and Services Classification**

CLASS 1

01. Chemicals used in industry, science, photography, agriculture, horticulture and forestry (including biological preparations used in industry and science, pectin, lecithin, enzymes and preservatives used in the food industry, vitamins, preservatives and antioxidants used in cosmetics)
02. Fertilizers and soils.
03. Unprocessed artificial resins and unprocessed plastics.
04. Fire extinguishing agents.
05. Adhesives except for stationery, medical and household use.



CLASS 2

01. Paints, varnishes, lacquers, rust inhibitors, wood preservatives, binders and thinning agents for paints, paint pigments, coating agents (in the form of paint), metal preservatives, shoe polishes; printing inks and inks, toners (including toner cartridges in solid form); substances for coloring foodstuffs, medicinal products and beverages.
02. Unprocessed natural resins.
03. Metal sheets and powdered metals for painters, decorators, printers and artists.



CLASS 3

01. Bleaching and cleaning agents; detergents, bleaches, fabric softeners, stain removers, dishwashing agents, cloths impregnated with cleaning agents.
02. Perfumery, perfumery-impregnated wipes, cologne wipes; cosmetics, non-drug cosmetics, fragrances for personal use and places (including deodorants for humans and animals).
03. Soaps (except soaps containing pharmaceuticals).
04. Dental care products: toothpastes, tooth polishing and whitening agents, non-medicated mouthwashes.
05. Abrasive products: emery cloths, sandpaper, pumice stones, abrasive pastes.
06. Polishing and care products for leather, vinyl, metal and wood: polishes, care creams, waxes for polishing.



CLASS 4

01. Industrial oils, greases, cutting fluids, dust absorbents, wetting and binding agents.
02. Solid fuels; coals, wood.
03. Liquid and gaseous fuels; gasoline, diesel, liquefied petroleum gas, natural gas, fuel oil and their non-chemical additives.
04. Candles, wicks, semi-finished waxes, beeswaxes (waxes), paraffins for lighting purposes.
05. Electric energy.



CLASS 5

01. Medicines for human and animal health, chemical products for medical and veterinary purposes, radioactive chemicals for medical and veterinary purposes, cosmetics containing medicines.
02. Dietetic substances suitable for medical and veterinary use; dietary supplements for humans and animals, food (nutritional) supplements; medical preparations for weight loss; infant formulas; plants for medicinal purposes and herbal beverages for medicinal purposes.
03. Products for dentistry (excluding instruments/devices); dental filling materials, dental molding materials, denture and artificial tooth bonding and repair materials.
04. Hygiene products; pads, tampons, medical moxibustion, dressing materials, diapers for children, adults and pets made of paper and textiles.
05. Substances that destroy harmful insects, harmful plants, harmful fungi and rodents.
06. Deodorants, air purifiers and deodorizers, except those for humans and animals.
07. Disinfectants, antiseptics (germicides), medical detergents, medicated soaps, disinfecting soaps, antibacterial hand lotions, hygiene wipes impregnated with disinfectant or antibacterial lotion.

CLASS 6

01. Non-precious mineral ores.
02. Ordinary metals and their alloys and semi-finished products: rebar; wire mesh and wires of ordinary metals for construction; ordinary metals in sheet, billet, bar, profile, plate, sheet.
03. Materials and tools made of metal for sheltering, storing, preserving, covering, wrapping, enclosing, enclosing, storing, placing; structures made of metal, mobile homes made of metal, metal boxes, metal packaging, metal fences, railings, metal tubes, metal containers, metal warehouses, metal shipping crates, metal portable stairs.
04. Doors and windows made of metal, shutters, blinds and their frames.
05. Metal cables, wires not for electricity.
06. Hardware (hardware) articles of metal; screws, nails, bolts, nuts, pins, washers, metal pitons for climbers, chains, metal furniture fittings and wheels, furniture and bed wheels made of metal, door and window handles, metal hinges, espagnolettes, metal locks, lock keys, metal key carrying rings, metal rollers.
07. Ventilation ducts, grilles, culverts, culvert covers, chimneys, chimney caps, manhole covers, gratings for ventilation, heating, sewerage, telephone, underground electrical and air conditioning installations made of metal.
08. Materials made of metal for indication, orientation, indication, identification: signs, boards, license plates, non-illuminated traffic direction signs made of metal.
09. Pipes, drill pipes and fittings for the transportation of liquids or gases, made of metal: valves, sleeves, elbows, clips, extensions, of metal.
10. Coin safes.

11. Railway materials made of metal: rails, rail joints, turnouts.
12. Metal pier bollards and buoys, metal pontoons, anchor anchors for marine vessels.
13. Metal molds for casting works (except for machine parts).
14. Works of art made of base metals or their alloys; trophies awarded in competitions made of base metals.
15. Caps made of metal, bottle caps.
16. Metal poles, metal uprights, metal scaffolds, metal scaffolds, metal piles
17. Metal pallets for lifting, loading and transportation, metal ropes, metal slings, ties, columns, straps, belts, bands and strips for lifting and transporting loads.
18. Metal chocks for vehicle wheels.
19. Profile slats made of metal for vehicles (for decoration).

CLASS 7

01. Machines, machine tools and industrial robots, three-dimensional printers used for the processing and shaping of wood, metal, glass and plastic materials and mines.
02. Construction machinery: dozers, backhoes, excavators, road construction and paving machines, drilling machines, rock drilling machines, sweepers and robotic mechanisms with the same function.
03. Lifting, transporting and conveying machines: elevators, escalators, cranes, robotic mechanisms with the same function.
04. Machines and robotic mechanisms used in agriculture, animal husbandry, agricultural sectors and grain/fruit/vegetable/food processing, beverage making and processing machines.
05. Engines, electric motors, their parts and assemblies, except for those for land vehicles; hydraulic and pneumatic controls, brakes and brake pads, except for those for land vehicles; crankshafts, gears, cylinders, pistons, turbines, filters; parts used in land vehicles and included in this class; oil, fuel, and air filters for vehicles, exhausts, exhaust manifolds, cylinders, cylinder heads, pistons, carburetors, fuel conversion devices, injectors, fuel economy devices, pumps, valves, starters, dynamos, spark plugs.
06. Bearings, ball or roller bearings.
07. Tire dismounting and mounting machines.
08. Alternators, generators, electric generators, solar-powered generators.
09. Painting machines, automatic paint spray guns, electric, hydraulic and pneumatic punching machines and guns, electric adhesive guns, guns for compressed air or liquid spraying machines, electric hand drills, chainsaws, jigsaws, spiral machines, compressed air generators, compressors, car washers and robots with the same function as the machines and tools listed above.

10. Electric and gas welding machines, electric arc welding devices, electric soldering devices, electric arc cutting devices, electric welding machine electrodes and robots with the same function.
11. Printing machines.
12. Packaging machines, filling-sealing and capping machines, labeling machines, sorting machines and robots and robotic mechanisms with the same function as the above-mentioned machines (including electric plastic sealing/sealing devices [packaging]).
13. Textile machines, sewing machines and industrial robots with the same function; sewing machine needles.
14. Pumps that are not part of a machine or engine (including fuel filling and dispensing pumps and their guns).
15. Kitchen electrical appliances for chopping, grinding, crushing, whisking and crumbling; washing machines (including washing machines for washing clothes/dishwashers, non-heated centrifugal tumble dryers); electric machines for cleaning floors, carpets or upholstery, vacuum cleaners and parts thereof.
16. Vending machines.
17. Galvanizing and electroplating machines.
18. Electric opening and closing mechanisms.
19. Cylinder seals for machines and engines.
20. Clutch linings for machines and engines, except for those land vehicles.

CLASS 8

01. Forks, spoons, knives and non-electric cutting utensils for cutting, chopping and peeling, including those made of precious metals.
02. Cutting and stabbing weapons.
03. Tools included in this class used for beauty and personal care; shaving, epilation, manicure, pedicure tools, hand tools for hair straightening and curling, scissors.
04. Hand tools (non-electric and non-motorized) for machinery, equipment and vehicle repair, construction, agriculture, horticulture and forestry.
05. Electric and non-electric steam irons.
06. Tool handles made of all kinds of materials.




CLASS 9

01. Measuring instruments and apparatus, including those for scientific, nautical, topographical, meteorological, industrial and laboratory use; non-medical thermometers, barometers, ammeters, voltmeters, moisture meters, testers, telescopes, periscopes, binoculars, magnifying glasses, compasses; vehicle gauges; materials used in laboratories; microscopes, experimental materials and apparatus.
02. Devices for the recording, transmission or reproduction of sound and image; cameras, cameras, televisions, videos, CD-DVD recording and player devices, MP3 players and remote control devices used with them, computers, desktop-tablet computers, wearable technological devices (smart watches, wristbands, head-mounted devices), microphones, speakers, headphones; devices for communication and reproduction purposes and computer peripheral equipment; mobile phones and their cases, mobile phone screen protectors; fixed telephones, telephone exchanges, computer printers, scanners, photocopiers, 3D glasses.
03. Magnetic and optical recording carriers and computer programs and software recorded on them; electronic publications, mobile applications, cryptocurrencies (software), non-fungible tokens (Qualified Intellectual Property) that can be downloaded via computer networks and recorded on magnetic and optical media; cards with magnetic/optical readers, motion pictures, series and video music clips recorded on magnetic, optical and electronic media.
04. Antennas, satellite antennas, amplifiers and their parts.
05. Ticket vending machines, cash machines.
06. Elements used in the electronics of machines and devices; semiconductors, electronic circuits, integrals, chips, diodes, transistors, magnetic heads, deflectors; electronic locks, photocells, electronic opening and closing mechanisms and remote control devices used as part of them, sensors.

07. Meters and timers that measure the amount of consumption per unit time.
08. Protective clothing, protective and life-saving equipment, swimming goggles, protective goggles.
09. Control devices and tools for the transmission, conversion, storage of electrical energy; plugs, junction boxes, switches, switches, fuses, ballasts, starters, electrical panels, resistors, sockets, transformers, adapters, chargers, cables used in electricity, electronics, batteries, accumulators, solar panels for electrical energy generation, charging stations for electric vehicles.
10. Devices whose main function is warning and alarm (except vehicle alarms), electric bells.
11. Signaling, signaling devices and tools for use in traffic.
12. Fire extinguishing appliances and devices, including vehicles for fire extinguishing purposes (including fire extinguishing hoses and fire extinguishing valves).
13. Radars, submarine radars (sonars), instruments and devices for providing or enhancing night vision.
14. Decorative magnets.
15. Metronomes
16. Humanoid robots with artificial intelligence, laboratory robots, robots for education, robots for security surveillance.

CLASS 10

01. Surgical, medical, dental and veterinary instruments, devices and furniture.
02. Artificial organs and prostheses.
03. Medical orthopedic materials: medical corsets, orthopedic shoes, elastic and supportive bandages.
04. Operating room suits and sterile drapes, medical masks.
05. Instruments and materials for sexual purposes.
06. Condoms (condom/cap).
07. Feeding bottles, bottle nipples, pacifiers, teether for babies.
08. Bracelets and rings for medical purposes, anti-rheumatic bracelets and rings.
09. Eyeglasses, sunglasses, lenses, and their cases, covers, parts, and accessories.



CLASS 11

01. Lighting devices (lighting fixtures for vehicles, indoors and outdoors).
02. Solid, liquid, gas and electric heating appliances; combi boilers, boilers, heating boilers and honeycombs, heat exchangers, stoves, ranges; solar energy collectors.
03. Steam, gas and smoke generators; steam generators (boilers), acetylene generators, oxygen generators, nitrogen generators.
04. Air conditioning and ventilation devices.
05. Coolers and freezers.
06. Electric and gas-powered appliances, machines and devices for cooking, drying and boiling; ovens, electric pots, electric kettles, electric water boilers, barbecues, barbecues, electric clothes dryers, hair dryers and hand dryers.
07. Plumbing products; faucets, shower sets, toilet inner sets, bathroom-shower cabins, bathtubs, toilets, sinks, washbasins, gaskets for faucets, washers (faucet inner set), faucet tips.
08. Water softening devices, water treatment devices, water treatment installations, waste treatment installations.
09. Non-medical electric underpads and electric blankets, heating pads, electric or non-electric foot warmers, hot water bags (thermophores).
10. Filters and filter-motor combinations for aquariums.
11. Industrial cooking, drying and cooling installations.
12. Pasteurizing and sterilizing machines.

CLASS 12

01. Motor vehicles (including motorcycles, scooters) and engines, clutches and transmission couplings, transmission belts and chains, gears, brakes, brake discs and pads, chassis, bodywork, suspensions, shock absorbers, transmissions, steering wheels, wheels, forklifts, caravans (including motorhomes and towed ones).
02. Bicycles and their frames, handlebars, mudguards, saddles.
03. Vehicle bodies, tipper bodies, tractor trailers, refrigerated bodies, trailer hitches.
04. Vehicle seats, head restraints for seats, child safety seats, seat covers, vehicle covers (shaped like the vehicle), sun visors.
05. Arms for direction signals, wipers for vehicle windows, wiper arms.
06. Inner and outer tires for vehicles, tubes tires, tire repair kits, patches for vehicle tires, welding patches, valves for vehicle tires.
07. Vehicle windows, safety vehicle windows, rear-view mirrors and side mirrors for vehicles.
08. Skid chains.
09. Roof racks for vehicles, bicycle and ski carriers
10. Tire inflator pumps.
11. Burglar alarms, reversing alarms, horns for vehicles.
12. Seat belts for passengers, air cushions.
13. Baby carriages, wheelchairs, strollers.
14. Wheelbarrows, market carts, single or multi-wheeled trolleys, market carts, wheeled carriers for household goods.

15. Rail vehicles: Locomotives, trains, trams, wagons, cable cars, cable cars, chair lifts.
16. Watercraft and parts (except engines).
17. Aircraft and parts (except engines). Drones, unmanned aerial vehicles.
18. Clutch linings for land vehicles.



CLASS 13

01. Firearms, pneumatic and spring-loaded weapons and their holsters and suspension straps and ammunition used with them.
02. Heavy weapons, mortars, rockets, ammunition and explosives.
03. Fireworks.
04. Protective gases for personal use.



CLASS 14

01. Jewelry (including imitations); precious metals, jewels, precious stones and jewelry made of them, cufflinks, tie pins, sculptures and trinkets made of precious metals, key rings of all kinds of materials.
02. Watches and timekeeping devices (including chronometers and parts, watch bands).
03. Trophies made of precious metals awarded in competitions.
04. Rosaries.



CLASS 15

01. Musical instruments and enclosures.




CLASS 16

01. Paper, cardboard (paperboard); packaging and wrapping materials made of paper or cardboard, cardboard boxes; products for one-time use made of paper (except stationery): paper towels, toilet paper, paper napkins.
02. Packaging and wrapping materials made of plastic materials; plastic bags, stretch films, nylon sheets for wrapping and packaging
03. Printing and binding materials.
04. Printed publications, printed documents: books, magazines, newspapers, invoices, delivery notes, income receipts, calendars, posters, photographs, banners, paintings, stickers, stamps.
05. Stationery, office, educational, teaching, writing, drawing, painting and materials for artists (excluding furniture and appliances): stationery paper products, adhesives, pencils, erasers, stationery tape, cardboard for handicrafts, writing paper, copy paper, cash register paper rolls, drawing instruments, blackboards, painting paints.
06. Office machines.
07. Brushes and rollers for whitewashing and painting.

CLASS 17

01. Rubber, gutta-percha, rubber, amyant (asbestos), mica or semi-finished synthetic materials in powder, sheet, rod and foil form.
02. Insulating, filling and sealing materials; paints used for insulation, fabrics for insulation, tapes for insulation, covers for insulation, joint sealants, gaskets, o-rings (except gaskets for engines, cylinder gaskets and taps)
03. Bendable tubes, hoses (including those used for vehicles), pipe sheaths and fittings made of rubber, plastic or rubber; textile hoses, nonmetallic pipe sheaths, fittings and connections, hose fittings, radiator hoses for vehicles (except fire hoses), spray nozzles.
04. Profile slats made of synthetic materials for vehicles (for decoration).



CLASS 18

01. Processed or unprocessed hides and skins, artificial skins, leather, leather for lining.
02. Articles not included in other classes for transport purposes made of leather, imitation leather or other materials; bags, wallets, leather or leather leather boxes and trunks, key cases, suitcases, suitcases.
03. Umbrellas, parasols, parasols, sunshades, canes.
04. Whips, harnesses, saddles and their parts, collars for pets, clothes for pets.



CLASS 19

01. Unformed materials included in this class: sand, gravel, crushed stone, asphalt, tar, cement, lime, plaster, concrete, block marble.
02. Concrete, plaster, earth, clay, clay, stone, marble, wood, plastic or synthetic materials for building/construction/road construction and similar purposes; non-metal buildings/structures, non-metal mobile homes, structural elements, poles, barriers, natural or synthetic heat sealable coatings, tarred cardboard for roofs, tarred coatings, doors and windows made of wood and synthetic materials, natural/artificial stone and ceramic tiles, floor coverings.
03. Metal, mechanical and non-illuminated traffic signs for roads.
04. Monuments and sculptures made of concrete, stone or marble.
05. Glass products for construction.
06. Prefabricated swimming pools made of non-metal.
07. Aquarium sand



CLASS 20

01. Furniture, clothes hangers, regardless of the materials and materials from which they are made
02. Bed mattresses, pillows, non-medical mattresses and pillows, seabeds
03. Mirrors
04. Beehives, artificial combs and honeycomb slats.
05. Mother laps for babies, playpens with bars (for indoors), baby cradles, walkers.
06. Boards made of wood or synthetic materials, pictures, frames for paintings, ID cards, dog tags, name tags, labels.
07. Packaging made of wood or synthetic materials, barrels, drums, barrels, drums, containers (tanks), boxes, packaging containers, containers for transportation, crates, transport pallets, covers used with them.
08. Hardware (hardware) made of wood or synthetic materials, furniture fittings, opening and closing devices.
09. Ornaments and decorations made of wood, cork, reed, bamboo, straw, horn, bone, ivory, whalebone, whalebone, oyster shell, amber, mother-of-pearl, meerschaum, wax, plastic or plaster included in this class; trinkets, wall hangings, sculptures and competition trophies made of the above-mentioned materials.
10. Baskets, fishing baskets.
11. Kennels, nests, beds for pets.
12. Portable ladders made of wood or synthetic materials, movable ladders.

CLASS 21

01. Non-electric cleaning tools and utensils; brushes except paint brushes, steel shavings, sponges, steel wool, tops, textile cleaning and wiping cloths, dishwashing gloves, non-electric polishing machines, carpet sweepers, floor mops with sticks.
02. Toothbrushes, electric toothbrushes, dental floss, shaving brushes, hairbrushes, makeup brushes, combs.
03. Household and kitchen utensils (excluding forks, knives, spoons), including those made of precious metals, included in this class and not working with electricity; food service sets, pots and pans, bottle openers, flower pots, straws, non-electric cooking utensils, grills that do not work with electricity and gas and skewers for use with them, carboy water pump (including battery, rechargeable), Plant watering containers and their caps, strainers, and spray nozzles.
04. Ironing boards and covers, clothes dryers
05. Cages, aquariums, vivariums, terrariums for pets.
06. Ornamental and decorative items made of glass, porcelain, ceramics, clay: statues, trinkets, vases and competition trophies made of these materials.
07. Mousetraps, insect traps, electrical devices for repelling or destroying flies and insects, fly catchers, fly racquets.
08. Perfume burners (burners that emit fragrance when lit), perfume sprays and vaporizers (sprayers), electric and non-electric make-up removers, powder puffs, boxes for toiletries.
09. Unprocessed glass, semi-processed glass, glass mosaics and glass powders for decoration (except for construction), glass wool (not for insulation and textile purposes).

CLASS 22

01. Ropes, ropes, rope ladders, hammocks, fishing nets.
02. Tents, awnings, tarpaulins, sails, vehicle covers (not in the form of vehicles).
03. Packaging bags made of textiles, bags for material transportation and storage, sacks, sacks, scraps, dirty goods bags.
04. Rubber and non-synthetic upholstery filling materials (including wool, cotton).
05. Synthetic fibers for textile purposes, virgin spun fibers, glass fibers.



CLASS 23

01. Twisting yarns for textile purposes; sewing, embroidery and knitting yarns, hyphens, flexible yarns.



CLASS 24

01. Woven or nonwoven fabrics.
02. Home textiles; curtains, bedspreads, duvet covers, sheets, pillowcases, blankets, quilts, towels.
03. Textile flags, pennants, labels.
04. Swaddling blankets for babies.
05. Sleeping bags for campers.



CLASS 25

01. Inner and outer garments made of all kinds of materials except for protective purposes; bathrobes, socks, scarves, scarves, shawls, bandanas, scarves, belts.
02. Footwear: shoes, slippers, sandals.
03. Headwear: hats, caps, beanies, berets, skullcaps, caps.



CLASS 26

01. Laces and embroidery (appliqués), guipures, scallops, narrow weaves, ribbons and ribbons, extraphores, wicks, ready-made letters and numbers made of fabric for garments, coats of arms, rank insignia, padding.
02. Buttons, clasps, eyelets, zippers, shoe and belt buckles, rivets, adhesive tapes, ties, pins, needles, sewing needles (except sewing machine needles), crochets and knitting needles, needle boxes and pincushions for clothing.
03. Fake flowers, fake fruits.
04. Hairpins, rings for tying hair, tiaras, hair ornaments not made of precious metals, false hair, hairpieces, hairpins, electric or non-electric curlers.



CLASS 27

01. Carpets, rugs, runners.
02. Prayer rugs
03. Linoleum, artificial grass, upholstery cork linoleum (linoleum).
04. Cushions for sports purposes.
05. Wallpapers



CLASS 28

01. Games and toys.
02. Indoor games; devices, machines and apparatus (including coin-operated) for games that can be connected and played with an external screen or monitor.
03. Toys for animals.
04. Toys for playgrounds, parks and playgrounds.
05. Gymnastic and sports equipment included in this class; fishing tackle, artificial fishing lures, traps for hunting and fishing.
06. Artificial Christmas trees and decorations for them, artificial snow, rattles, materials for parties and similar entertainments, paper party hats.



CLASS 29

01. Meat, fish, poultry and game meat and all kinds of processed meat products.
02. Dry pulses.
03. Instant soups, bouillon.

CLASS 34
